- Open to everyone, no nonmember fees. (1D=fastest time, 2D+.5 second, 3D+1 second, 4D+1.5 seconds, 5D+2 seconds)
- \$2500 PESI OPEN BONUS (\$1250 each day, must enter Open, must belong to WPRA and horse[s] PESI enrolled).
- \$2000 BARREL BREEDERS INCENTIVE OPEN 4D SIDEPOOT SATURDAY, for eligible BBI horses of any age
- \$250 added Saturday WPRA Sidepot • Open WPRA co-approved both days
- Riders may not switch their horses' positions. Horses must be run as they appear in the draw
- Dress code: Cowboy hat or helmet, long-sleeved shirt, western pants and boots are required attire
- A knocked down barrel results in a no-time (WPRA/PESI sidepots there is a 5-second penalty for each knocked down barrel)
- UBRC Top Guns, Ledge Guns (50 & over) and Young Guns (18 & under) sidepots Saturday and Sunday, roll from Open
